4/ First-aid measures

In the event of skin contact

Take off contamined clothing. Wash immediately with soap and plenty of water. If irritation, get medical advice.

In the event of eye contact

Flush immediately with plenty of flowing water for at least 10 minutes, holding eyelids apart. Consult an ophtalmologist.

In the event of ingestion

I swallowed, rinse mouth with water. DO NOT induce vomiting. Get medical advice, showing label information .

In the event of excessive inhalation

Move the victim to fresh air. Get medical advise immediately.

Stop the substance to enter into drains and groundwater.

Prevent spreading over a wide area.

6.3 Cleaning methods

Limit the dispersion of the product.

Absorb the liquid with an inert absorbent, such as oil or sand.

Wash with a grease extractor.

Get rid of the duster and sponges used, according to local regulations.
